#### **Residuary gift**



We have put together this useful guide that takes you through two important topics for legacy preparation; your favourite things and the important things.


So please read through our guide carefully, fill it out, and share it with those people who will need it. We also recommend keeping a hard copy along with your important life documents, including your Will.
